

### Solventum™ Medical Tape 9917

**Composition** Tape is typically ~13 mils [0.3 mm] thick without release liner

<b>C-NW carrier</b>		1.3 oz./yd <sup>2</sup> (40 g/m <sup>2</sup> ) Polyester spunlace nonwoven carrier
<b>D-Acr adhesive</b>		Non-tackified acrylic-based PSA [faceside]
