


Custom options — technical reference guide



One service is converting the tape into widths and lengths specific to our customer's requirements. We also can provide slit liner (SL) and/or extended liner (EL) on many of our tape products.

Slit liner and extended liner capabilities

Slit liners (SL) — liner is "scored" (not cut through totally) or "slit" through to (but not through) the tape


- Available on all products on a release liner except:
- Transfer adhesives #1504, #1524 and #1524A
- Polyurethane tapes & film #9832F, #9833, #9834 and #9836.
- Tolerance is +/- 1/16" (+/- 1.5mm)
- Standard maximum slit roll width is 24" (61cm) and minimum slit width is 0.5" (1.27cm)
- Slit (or score) must be a minimum of 1/8" (3mm) from the roll edge
- Orders must include total number and location(s) of slit(s) and distance from the left edge






Extended liners (EL) — liner extends past the edge or edges of the adhesive

- Available on all products with a release liner except:
 - any foam tape
 - Transfer adhesives #1524 and #1524A
 - Hydrogel adhesive #9880
- All other products have an EL minimum width of 1/8" (3mm) and tolerance is +/- 1/16" (+/- 1.5mm)
- Standard maximum roll width is 24" (61cm) and minimum slit width is 0.5" (1.27cm)





Note: Please be aware that there may be some restrictions on maximum roll length of any product slit less than 1" (25.4mm) wide due to roll stability during handling.
