## Custom edit capabilities explained

Allows users to create custom edits to help guide correct, consistent and accurate coding according to an organization's unique coding needs.

Helps increase coder productivity with custom edits displayed at the point-of-coding in the Solventum CRS+ workflow.

Based upon severity of ranking, a coder can be required to address the edit before proceeding, thus increasing accuracy and reducing rework.

## Reminders where and when they're needed

The Solventum CRS+ contains a special feature called "custom edits," which allows organizations to create and deploy customizable coding edits to meet their unique coding needs.

Custom edits can be created based on priority and specific data points, requiring the coder to address the edit notification before completing the record. This helps organizations set up their preferred edits to trigger both indisplay notifications and hard stops at the time of coding.

The result? A streamlined coding workflow, decreased record rework, and fewer days not final billed (DNFB).

### The challenge

Coders are responsible for moving medical records quickly and accurately through the revenue cycle, while also remembering and applying a litany of rules, regulations and organization-specific coding practices as they code.

But coders are human and human errors happen. When there are issues with records that require audits and rework, record completion can be delayed for weeks or even months. Such delays have a significant negative impact on revenue recognition and patient billing.



#### Client-created edit

The example shown below is a custom edit created by a Solventum client to remind coders to check for this compliance issue at the time of coding.

Custom edit: CPT 12001-12021 (simple suture) is present – ensure that corresponding revenue code is assigned. We have seen situations where the ED department charges a 450-revenue code for a simple suture, but the ED coder assigns CPT 12031 for intermediate repair.

- 12031-12057 Intermediate Repair
- 13100-13160 Complex Repair
