


## Technical information sheet

### Solventum™ Medical Tape 1522H

Effective: April 2023

Supersedes all previous information sheets



### Features and benefits

- No natural rubber compounds used
- Clear, conformable film carrier
- High adhesion acrylic-based adhesive
- Excellent adhesion to a wide range of substrates

**Composition:** Tape is typically ~13 mils [~0.33 mm] thick without release liner

<b>A-Paper liner</b>		Yellow Kraft paper, 2-sides [DC] Si Rel. (~5.5 mils/~0.14 mm)
<b>B-Acr adhesive</b>		~6 mils high adhesion acrylic medical adhesive (backside)
<b>C-PE carrier</b>		~1.2 mil (0.03 mm) clear polyethylene film carrier
<b>D-Acr adhesive</b>		~6 mils high adhesion acrylic medical adhesive (faceside)

<b>Adhesion to polypropylene, 180 deg peel, face side</b>	61 ounces/inch width (~17 N/25.4 mm width)
<b>Liner release, 180° peel</b>	30 gm/inch width (0.29 N/25.4 mm width)

**Roll description:** Tape supplied on 3-inch (7.6 cm) diameter cores. Liner side out

<b>Length, maximum</b>	109 yards (100 meters)
<b>Width, maximum</b>	23.6 inches (60 cm) ± 0.31 inches (1 mm)

**Splices:** Splices on the tape are intended for continuous processing

<b>Roll width</b>	≤ 8 inches (20 cm)
<b>Maximum number of splices per roll</b>	2 per 109 yards (100m)

### Recommended storage & preliminary rollstock shelf life

Product as supplied in original packaging will maintain stated properties for a period of two (2) years from date stamped on the shipping container when stored at temperatures of 50–80°F (10–27°C) and a relative humidity between 40–60 percent.
