#### Executive summary

Worcestershire Acute Hospitals NHS Trust (WAH NHS Trust). serving a population of over 603,000 across three hospital sites, has significantly enhanced the quality, accuracy, and depth of its clinical coding through the implementation of the Solventum™ Intelligent Analytics Suite.

The Trust reinforced its strategic commitment to clinical coding as a critical enabler of high-quality patient care, effective funding management, and a meaningful contribution to national data initiatives.

Through the implementation of Solventum's Intelligent Analytics Suite, WAH NHS Trust has transformed the way its coding team operates. Automated nudges now identify missed opportunities in real time, enabling coders to work more efficiently, improve audit outcomes, and ensure accurate, policy-aligned reimbursement.

As a result of these improvements, the Trust identified approximately £1.5 million in appropriate reimbursement opportunities during 2024/25. However, the actual financial benefit realised was subject to national funding constraints, including the block contract and the Elective Recovery Fund (ERF) cap.

This enhancement reflects the Trust's strengthened capability to accurately capture the complexity of care delivered, ensuring clinical data integrity, supporting better clinical decisionmaking, and maintaining alignment with national reimbursement frameworks.

### The challenge

In the post-pandemic NHS landscape, Trusts nationwide face unprecedented pressure to reduce elective care backlogs while maintaining financial sustainability. With the ERF's payment mechanisms directly linking accurate coding to funding allocations, maintaining the high levels of coding accuracy rate while processing increased volumes became mission critical.

The WAH NHS Trust needed a solution that would enhance coding precision while ensuring all reimbursement claims reflected genuine clinical activity.

#### Results and impact

The WAH NHS Trust has achieved significant improvements in both coding accuracy and financial outcomes:

- Identified additional appropriate annual reimbursement of £1.5 million
- Enhanced depth of clinical coding, capturing complete comorbidities and complications
- Achieved average coding completeness of 95% within prescribed deadlines
- Significantly improved documentation quality across specialties through feedback
- · Reduced coding errors in critical areas affecting payment, including:
  - Primary diagnosis selection
- Comorbidity documentation
- Procedure code sequencing Length of Stay (LoS) accuracy

#### Solventum solution implementation

## Process excellence and clinical integration

The WAH NHS Trust has established a robust quality improvement cycle where:

- Regular education sessions between clinicians and clinical coders build mutual understanding
- Consultants from key specialties now attend monthly coding review meetings
- Documentation quality improvements are implemented before Secondary Uses Services submission
- Monthly specialty-specific coding accuracy reports highlight improvement opportunities

## Solventum Medical History Assurance (MHA)

MHA is designed to facilitate the accurate recording of case mix by prompting coders to review relevant medical history based on previous patient records. Integrated directly into the coding workflow, it helps coders:

- Identify historical comorbidities that may impact the HRG
- Reduce omissions of critical diagnoses during coding
- Assure accurate and complete clinical representation of the patient episode

By enabling proactive validation of co-morbidities and patient complexity, MHA helps clinical coding teams capture a more complete clinical picture, resulting in more accurate HRGs and, consequently, appropriate reimbursement.

## Solventum Data Quality Analytics (DQA)

DQA is specifically designed to validate assigned clinical coding and related HRG allocations. Built within the Medicode encoder, the DQA module offers:

- Real-time feedback during the coding process
- · Actionable insights displayed via a centralised dashboard
- Immediate visibility of discrepancies or anomalies that may affect accuracy or financial impact

This module not only enhances the productivity of the coding team by allowing high-frequency validation but also plays a crucial role in staff development – highlighting areas for individual or team training when recurring errors are identified.

## Solventum Data Quality Analytics interactive (DQAi)

DQAi supports real-time error interception and coding validation by:

- Prompting coders to resolve issues before submission
- Highlighting missing or mis-sequenced diagnoses and procedures
- Flagging potential HRG impacts tied to documentation and Length of Stay

This tool ensures high data integrity while also reducing downstream audit burdens and resubmission rates.

## Solventum Integrity Plus for Audit

The Trust's use of Integrity Plus has enabled a high-impact, targeted auditing strategy. The team:

- Reviews daily batches of coded data
- Focuses audits on high-value clinical areas (e.g. Oncology, LoS outliers)
- Provides direct feedback to coders and supports documentation improvements
- Aligns internal auditing with governance standards and specialty leads

#### Looking ahead

As the NHS continues to emphasise elective recovery, waiting list reduction, and accurate resource allocation, this WAH' NHS Trust's investment in data quality and clinical engagement stands as a model of best practice.

By combining intelligent analytics, thoughtful auditing, and strong cross-functional collaboration, the Trust is not only ensuring appropriate reimbursement, it is building a future-proof framework for accurate, compliant, and clinically meaningful data.
